# LETTER FROM OUR PRESIDENT & CEO





Jennifer Dubrow Weiss, CEO

This past year has been an exciting one for the Jewish Federation of Southern New Jersey and our family of agencies. We celebrated our 100th anniversary together as a community with classic, familiar events like Super Sunday and made plans for new ones like FedFest100. Even more thrilling were the exceptional accomplishments that allowed us to make a positive and meaningful impact in our South Jersey community and around the world – together – in true *Tikkun Olam* fashion.

In April, with help from The Jewish Federations of North America (JFNA), we boarded a plane to the Ukraine-Poland border and delivered over-the-counter medical supplies collected from our beloved community to help the refugees. Additionally, thanks to our generous donors, we raised more than \$235,000 for the Ukraine Relief Fund, which helped people make Aliyah to Israel, secured temporary housing for those in transit, trained staff to manage medical crisis needs in schools, and more to address this humanitarian crisis. We knew that as we headed over to the border, we were not just bringing ourselves, but the hearts of all in our community. The immense gratitude we feel in representing our Federation family for this boots-on-theground experience is truly indescribable.

We at Federation have made a concerted effort to find sustainable solutions that help support our environment. Thanks to our partnership with Ecosave, earlier this year we installed solar panels on the rooftop of the Jewish Federation building to help curb carbon emissions. This is one of several green projects that we launched over the last decade to be an eco-friendly organization; and since the Ecosave partnership began, we have reduced our building's carbon emissions by 7,551,831 kWh of electricity and 26,381 therms of natural gas, equating to 5,494 metric tons of CO<sub>2</sub> saved.

With the global rise in antisemitism – such as the bomb threats we personally experienced here – we remain committed to expanding security for our Jewish community. In the past year, we raised over \$500,000, including a \$100,000 Homeland Security grant, to increase our community's protection. Our security leaders are hard at work collaborating with others in the region to ensure that our South Jersey Jewish community can live and observe their religion safely.

These few initiatives are only several spotlights of the incredible work passing through our system and across each agency that includes the Katz Jewish Community Center, Samost Jewish Family & Children's Service, Jewish Community Relations Council, Jewish Community Voice, Jewish Senior Housing and Healthcare Service, Jewish Community Foundation, Inc., and Jewish Community Properties.

We are so grateful to our lay leaders, staff, donors, volunteers, and partners who have truly put our mission into action and look forward to seeing the impact we will make together in the years to come.
